Carry The Fire will also be a springboard for a historic fundraising campaign that we will launch publicly in 2026. It will have a major impact on cancer, both across Canada and around the world, by focusing efforts on three key areas:



Early Detection: Preventing cancer before it happens.



Innovative Treatments: Providing better, more personalized therapies.



Comprehensive Support: Addressing the full range of needs that cancer patients and caregivers have.

Today, cancer is still the leading cause of death in Canada. By 2050, it's projected that new cancer diagnoses will increase globally by 77%, with millennials seeing the greatest rise in cases. However, we are at a pivotal moment in history in cancer research, treatment, and care. Decades of research findings, alongside new technologies like Artificial Intelligence (AI), have the potential to transform cancer outcomes in a way we could never have imagined at any other point before. The Princess Margaret is poised to lead the charge, sustained by our community of dedicated supporters.

In this year's report, we are thrilled to share stories about visionary donors like Allan and Hinda Silber, and Richard Rooney and Laura Dinner, two families whose transformational gifts are enabling The Princess Margaret to fund life-changing, high-priority initiatives like the new Silber Family Theranostics Centre. EVERY BREAKTHROUGH FUELS A NEW DAWN

Princess Margaret Cancer Centre has had an extraordinary year filled with notable milestones.

The inspiring launch of The Princess Margaret Cancer Foundation's new brand campaign, Carry The Fire, rekindled our dedication to excellence in all that we do, and to serving patients with unwavering commitment.

We are proud to be named Canada's top oncology hospital by *Newsweek*, a testament to the hard work and expertise of our teams. We celebrated significant strides in early cancer detection, treatment, supportive care, and groundbreaking research. We also earned a perfect score from Accreditation Canada, with multiple programs at Princess Margaret Cancer Centre recognized for exemplifying "best practices."

As one of the world's leading cancer centres that looks to deepen its impact even further, The Princess Margaret is grateful for the dedication and support of The Princess Margaret Cancer Foundation.

Among this year's research discovery highlights:

- A study that showed how the combination of immunotherapy, standard radiation, and surgery can improve cancer-free survival in sarcoma patients by 15%.
- A study that found that the enzyme ADO is critical for cancer cell survival – a promising therapeutic target that would harm cancer cells, while sparing healthy tissues.
- Clinical validation for a blood test to detect head and neck cancer up to nearly 15 months earlier than traditional monitoring methods.
- An AI model that predicts how metastatic cancer will respond to treatment, offering a new path to manage metastasis.

On the clinical front, we celebrated many advancements, including:

- The launch of the second phase of renovations to expand cellular therapy facilities.
- The reopening of Princess Margaret Lodge, a home away from home for cancer patients.
- The expansion of the Princess Margaret Cancer Care Network, with Saskatchewan Cancer Agency, MacKenzie Health, and William Osler joining our four existing partners.
- A bilateral agreement with University of Waterloo in Cancer Data and Al.
- The expansion of our Cancer and the Arts Program, with three beautiful new works for all to enjoy.
- The installation of state-of-the-art radiation equipment in our Radiation Medicine Program.
- A record 200 allogeneic bone marrow transplants.

This year's achievements showcase our commitment to exceptional patient care, cutting-edge research, building partnerships at home and abroad, and innovative approaches to treatment. Carry The Fire represents the hope and determination of our patients, supporters, volunteers, learners, and dedicated staff. We couldn't do it without you.

Cancer remains the leading cause of death in Canada. The Princess Margaret Cancer Centre serves close to 19,000 patients a year, and the number of cases is growing here and around the world – forecast to rise by 77% globally between 2022 and 2050, with young people the most impacted.

At The Princess Margaret, we know that behind those statistics are individuals and their loved ones navigating the impacts of a devastating diagnosis. That's why here, and across University Health Network (UHN), Canada's leading research hospital, we are committed to taking action that builds on our legacy of research and innovation in cancer prevention, early diagnosis, treatment, and research to benefit patients in Canada and around the world.

Building on that legacy, UHN, with the support of The Princess Margaret Cancer Foundation, acquired 522 University Avenue. At 15 storeys and more than 210,000 square feet, this new building will help us grow our world-class care and research, focusing on cancer, Al. and education.

At The Princess Margaret, our drive for excellence has led to major breakthroughs such as the discovery of the stem cell, cutting-edge immunotherapy, advanced surgical techniques, and a cancer blood test which allows for detection at the molecular level. We treat the whole patient – emotionally and physically – and address diverse needs across all ages. Home to a world-leading clinical trials program, more than 20%

of patients at The Princess Margaret are enrolled in a clinical trial or study, something that helps transform standards of care through groundbreaking discoveries and shapes cancer care globally. Our innovations continue to influence cancer treatment worldwide, offering real hope for the future.

That hope is what Carry The Fire is all about, and why it is so important. It offers an opportunity for everyone – researchers, clinicians, community members, donors, patients, and their loved ones – to help sustain this vital work to improve cancer outcomes and fulfill the promise of brighter tomorrows.

This year, UHN also launched our Canada Leads 100 Challenge to attract early career scientists from around the world. We look forward to welcoming new recruits who will continue to build on our rich expertise and global leadership.

Between 2022 and 2050, global cancer cases will rise by 77%, with younger generations like millennials facing the steepest increases. Despite advancements that have raised Canada's five-year cancer survival rate, from 50% in the 1980s to nearly 63% today, the need for accelerated innovation has never been greater. The Princess Margaret, as a leader in global cancer care and research, is uniquely positioned to answer this call.

At its core, Carry The Fire reflects our collective responsibility to drive progress against a disease that impacts everyone. The campaign raises awareness of the groundbreaking work at Princess Margaret Cancer Centre, from revolutionary liquid biopsies for early cancer detection to advanced immunotherapies that harness the body's own immune system to eliminate cancer cells. These innovations improve rates of survival and redefine what is possible for patients around the world.

Equally vital is the campaign's focus on the breadth of cancer's impact on both patients and their loved ones. A cancer diagnosis affects every aspect of a person's life, taking a deep emotional toll on patients the people around them. A BEACON FOR THERANOSTICS RESEARCH AND CARE

In February of 2025, Allan and Hinda Silber made a landmark \$10-million commitment to support the establishment and operation of a world-leading theranostics centre at Princess Margaret Cancer Centre. In grateful recognition of their extraordinary dedication to create a world free from the fear of cancer, the new facility will be named the Silber Family Theranostics Centre.

Theranostics is a combined therapeutic and diagnostic approach that uses radioisotopes to both image and treat tumours for a more targeted and personalized method of cancer care.

Dr. Rebecca Wong, radiation oncologist and Co-Director of the Silber Family Theranostics Centre at The Princess Margaret explains, "Using a single molecular probe, the technique enables clinicians to identify tumours through nuclear imaging and then subsequently deliver cancerkilling radiation therapy directly to that location."

This past year, Princess Margaret Cancer Centre played a key role in making Pluvicto, a new theranostic medicine for advanced metastatic prostate cancer, accessible to all Canadians — a prime example of the journey from research-driven ideas to real-world application.

Thanks to the Silbers' remarkable gift, The Princess Margaret can continue to drive advancements in theranostics research, care, education, advocacy, and key industry partnerships. Their contribution also marks a significant milestone, bringing the Cancer Centre halfway to its \$30-million fundraising goal and underscoring the strong momentum behind this vital initiative.

Establishing the Silber Family Theranostics Centre holds special meaning for Allan and Hinda. They have both been deeply involved with The Princess Margaret for many years, with Hinda acting as the volunteer co-chair of Dance to Conquer Cancer multiple times, and Allan contributing his support both personally and professionally.

This \$10-million gift demonstrates the Silbers' long-time dedication and commitment to The Princess Margaret. As Allan describes it, "Helping to shape UHN and The Princess Margaret into a global leader in theranostics staffed with the world's top experts isn't just my goal, it's our family's legacy."



Read how one patient's breakthrough treatment at The Princess Margaret inspired his continued giving

Robert Kerrigan is a retired civil engineer who had a wonderful career working on projects in Canada and around the world. He lives in west Toronto and has two adult children who live close by. His daughter, Andrea, is a marketing manager for a consulting engineering firm and his son, Mike, is a nurse.

But back in 2008, Robert's life was flipped upside down when he was unexpectedly diagnosed with prostate cancer. At the time, his daily treatments at the Cancer Centre were quite new, using a precisely focused beam of radiation. "I wouldn't be here today if it wasn't for The Princess Margaret. That's a fact," says Robert.

It was this life-changing diagnosis and treatment that inspired him to give to The Princess Margaret. "They saved my life and I've been a donor ever since." For Robert, "ever since" has now meant an incredible 17 years of giving – more than 200 donations – that were all made possible by becoming a monthly donor.

Monthly giving has made it easy for Robert to give on a regular basis. He likes that he can make the same donation month after month, rather than trying to find the money in his budget to donate at the end of the year. Plus, he likes knowing that giving on a consistent schedule helps the Cancer Centre to plan more effectively for its future needs.

He also appreciates that The Princess Margaret is one of the world's leading cancer research and treatment centres, where new cancer therapies like the one that helped him survive are being developed. "As a monthly donor, I'm reminded every month that I'm still alive because of The Princess Margaret," he says, "And I might be helping to save someone else's life through the cancer research that I am supporting."

The Ride to Conquer Cancer, presented by Johnson & Johnson, reached new heights this year as it continues to reign as one of North America's largest cycling fundraisers. Over 4,200 Riders, including 1,000 new participants, helped raise over \$20 million, setting an extraordinary new fundraising record for life-saving cancer research and treatment at The Princess Margaret. Since it's inception, the Ride has raised over \$300 million, driving critical advancements in cancer care and offering hope to patients and families around the world. These remarkable achievements are a testament to the dedication and generosity of our incredible community.



Road Hockey to Conquer Cancer, fuelled by Longo's, set a new record with 140 teams raising \$3.17 million to drive cancer research breakthroughs at The Princess Margaret. This marks the first time the event raised over \$3 million in back-to-back years! Road Hockey continues to be one of Canada's best employee engagement and team-building events with NHL alumni, Canadian Olympians, and PWHL stars joining 1,500 players in our dusk-till-dawn event in Vaughan, Ontario. On game day, we didn't count wins or goals scored – instead we came together for our shared goal of a future free from the fear of cancer.





The Princess Margaret Lottery is Canada's largest charitable lottery, raising \$138.8 million gross last year. Every ticket purchase supported groundbreaking research that is transforming the landscape of cancer diagnosis, treatment, and care, while also providing a chance to win incredible prizes such as luxury real estate, cash, cars, and more. This past year, we also introduced several successful sweepstakes contests to better connect with our younger supporters and had the pleasure of awarding once-in-a-lifetime experiences, including tickets to Taylor Swift, the Super Bowl, and a Maple Leafs playoffs game.





The Princess Margaret Cancer Foundation launched our newest signature event – Cricket to Conquer Cancer, presented by TD. The landscape of sport continues to evolve in Canada, and cricket is quickly growing in popularity, presenting a fresh opportunity for new communities to share in The Princess Margaret's mission. On May 31, 2025, thousands of supporters took to the pitch with Carlos Brathwaite and other professional Canadian cricket players at the inaugural event, together making it Canada's largest street cricket fundraiser.



The 11th annual Journey to Conquer Cancer, presented by Starlight Investments, saw thousands of participants walk and run in this inclusive, family– and dog–friendly event. Together, they raised an incredible \$1.5 million for cancer research, contributing to the event's total of over \$15 million raised to date. A standout moment was the Multiple Myeloma Support Group celebrating their 20th anniversary, having raised an incredible \$10 million over 20 years toward advancing research through the Molly and David Bloom Chair in Multiple Myeloma. This year's event exemplified the community's collective power in supporting life–saving cancer care advancements.



The 22nd annual Walk to Conquer Cancer brought together over 1,800 passionate walkers, raising an impressive \$3.5 million to advance life-saving cancer research. Starting at Toronto's stunning Harbourfront, participants completed a half-marathon, demonstrating unwavering dedication to the cause. Recognized as Canada's single largest fundraising walk, this event has now contributed over \$195 million to support groundbreaking cancer research at The Princess Margaret.



Northern Pass to Conquer Cancer, powered by Pass It Along Foundation, reached a remarkable milestone this year, raising \$1.5 million and surpassing its ambitious \$1.2 million target. The event set a new fundraising record and even sold out for the first time! Celebrated as Muskoka's premiere cycling event, the Northern Pass continues to fuel life-saving cancer research through the dedication of its vibrant community.

A TEAM EFFORT AT THE OFFICE - AND ON THE ROAD

Since opening their real estate practice 25 years ago, longtime friends and business partners Satwinder Singh and Gurmeet Battu have been through many highs and lows together – including the rolling hills of Muskoka that the Northern Pass to Conquer Cancer takes them through.

While they've cycled thousands of kilometres together, it all started on stationary bikes at their local gym in Mississauga. One of the trainers there suggested they create a team for the Ride to Conquer Cancer, and though neither Satwinder nor Gurmeet had done anything like it before, both had experienced the pain and hardship of caring for a loved one with cancer. Sadly, Gurmeet's mother passed away from liver cancer at only 54 years old, and Satwinder's wife was diagnosed with breast cancer at just 33 years old.

"She was young and healthy. Cancer was the furthest thing from our minds," recalls Satwinder. "We knew about cancer, but we didn't know everything that people go through until it happened to us." Since her recovery, he always wanted to do something to give back, and so in 2012, team Realtors on Wheels was born.

"We love the people we ride with," says Gurmeet. "Cycling with so many other people, including cancer survivors, and learning their stories, is what inspires us to help as much as we can." Satwinder adds, "Gurmeet and I ride for fun. And even though it can be challenging at times to ride these long distances, and it can be painful, it's not as painful as what people with cancer are going through. Knowing that, that's what motivates us to do it again and again."

Ten years after creating their team, Satwinder and Gurmeet decided to switch gears and try another Princess Margaret fundraising event. "Northern Pass is very unique," says Gurmeet. "It's very beautiful in Muskoka. We love that it's smaller and we see the same people come back every year. They inspire us to keep coming back too."

Thank you to Satwinder and Gurmeet for their continued dedication to the Ride and Northern Pass and for helping to Carry The Fire for a world free from the fear of cancer. Their passion for helping others is evident in their remarkable fundraising, together raising over \$35,000 for breakthrough cancer research at The Princess Margaret. We look forward to cheering on Realtors on Wheels once again at the 2025 Northern Pass!

This esteemed society celebrates the extraordinary generosity of individuals, foundations, corporations, and unions who have collectively contributed \$1 million or more. Among the remarkable Till & McCulloch Society members is The Savvas Chamberlain Family Foundation, which gave a generous \$1-million donation to set the stage for brighter tomorrows in cancer care. This pivotal funding from The Savvas Chamberlain Family Foundation will propel the expansion of The Princess Margaret and UHN's digital pathology network to serve hospitals across Ontario. Digital pathology uses ultra-high-resolution images to interpret tissue samples, enabling more accurate, faster diagnoses when compared to traditional methods. The power of Al layered onto this technology unlocks unprecedented potential, helping pathologists detect cancer with unparalleled precision. The expanded network will also bring advanced diagnostics to remote and underserved communities, ushering in equitable access no matter where patients live.

"This gift will create a ripple effect," explains Dr. George Yousef, Medical Director of the Laboratory Medicine Program at UHN. "With the digitization of pathology, virtual consultations will connect specialists to patients in Northern Ontario and beyond, offering timely, life-saving diagnoses. Thanks to the Chamberlain family's vision, we are rewriting what's possible for cancer care."

Part of the donation will fund the digitization of extensive pathology archives, a collection of over 10 million slides. This monumental resource will enable researchers to uncover new insights into cancer biology, paving the way for major advancements.

The Princess Margaret is at the forefront of cancer diagnosis, treatment and care, thanks in part to the incredible generosity of Till & McCulloch Society members like The Savvas Chamberlain Family Foundation. Their contributions empower us to imagine and create a world free from the fear of cancer. By combining innovative technology with equitable healthcare, we are bringing hope to patients everywhere.

PAUL GAUTHIER: A GREAT LIFE, A GREAT LEGACY

Paul was a man who took the best that life had to offer and gave his best back to everyone around him. He loved working with others and was an avid traveller, cherishing his long career as a flight attendant, which gave him the opportunity to meet new people and travel around the world.

At home in Toronto, Paul was known as the "Mayor of Wroxeter Avenue," the street where he resided for almost 40 years. "He was a presence," says Daniel Kushner, Paul's longtime friend and neighbour. "He made friends everywhere he went. At our annual street party, he always hosted everyone at his place beforehand. He volunteered at our local farmer's market in Withrow Park. When anyone on our street got married, he was always invited to their wedding."


Paul's appetite for life charmed everyone he met, including the staff at Princess Margaret Cancer Centre. Diagnosed with prostate cancer in his 50s, he would make regular trips there over the next thirty years of his life. "He just loved the people he interacted with there – the volunteers, the nurses, his doctors. Every Wednesday, he'd attend the little concerts held in the atrium." Daniel recalls.

He was incredibly grateful for the warm care he received at The Princess Margaret and while undergoing treatment, Paul volunteered for every new clinical trial offered to him. But his desire to help the doctors who helped him through his recovery extended even further than clinical trials and the yearly donations he gave.

When Paul eventually passed away from causes unrelated to cancer at age 82, he also left a gift in his Will to The Princess Margaret. "Paul was a very principled person," says Daniel, who was also the Executor of Paul's Will. "He wanted to see his principles live on. Paul really believed in causes that were about providing compassionate care, and his gift to The Princess Margaret is a testament to his values."

Paul's legacy of generosity and community will continue to live on through his gift, which will support advancing prostate cancer research. Not only will it help researchers at The Princess Margaret think big and develop the next cancer breakthrough, but it will also help future generations live in a world free from the fear of cancer, ensuring they too can live their life to the fullest – just like Paul.

HOW THERANOSTICS SAVED A YOUNG MOTHER'S LIFE

The year was 2016. D'Arcy Bowker was 25, a competitive swimmer and runner. While training for a half-marathon, she kept blacking out. Her first thoughts were, "I didn't eat or drink enough." A physiotherapist diagnosed her with fitness headaches. D'Arcy went for a stress test and fainted on the treadmill. She was constantly exhausted and her blood pressure skyrocketed. The doctor advised her "No spikes in emotions or physical activity." After a year of being treated as though she were having repeated heart attacks, D'Arcy's doctor tested her adrenal glands. The finding: pheochromocytoma, a rare type of neuroendocrine tumour.

Surgeons removed the tumour and D'Arcy gave birth to her first child soon after.

Genetic testing showed that D'Arcy had an inherited gene mutation that could cause tumours to grow on any nerve bundle. Her sisters and daughter also tested positive for the mutation.

Then, while D'Arcy was pregnant with her second child, her medical team discovered a lesion on her liver. The cancer had metastasized and she had several small tumours. By this time, she was being seen by Dr. Shereen Ezzat, an endocrinologist at The Princess Margaret. Knowing that a regular course of chemo would not be effective, he referred her to Dr. Rebecca Wong, a radiation oncologist.

Dr. Wong, immediately enrolled D'Arcy in a Peptide Receptor Radionuclide Therapy (PRRT) clinical trial that she was running.

"If I didn't do this trial, there weren't a lot of other options for me. It's an incurable cancer," says D'Arcy. "It was all such a fast turnaround. I signed up in December 2020 and started in January 2021. Being able to take swift action was so important to my mental health at the time."

PRRT is a molecular targeted therapy that uses a needle to deliver high-dose radiation, in this case lutetium Lu 177 dotatate, directly to the tumour cells while minimizing harm to the surrounding tissue.

D'Arcy underwent four rounds of treatment, six weeks apart. Happily, the treatment was successful.

D'Arcy's cancer is currently at bay. She isn't cured; the cancer can return. But because she tolerated the procedure so well, D'Arcy knows she can undergo the treatment again when that time comes.

Her sisters are now routinely tested, and she keeps a close eye on her daughter.

"The joke in my family is that everybody owes me. But in all honesty, I'm so grateful. By being part of this clinical trial, I not only saved myself. I am saving others."

Her experience inspired D'Arcy to become a psychotherapist for people living with a chronic illness. And thanks to the care she received at The Princess Margaret, D'Arcy also just became a mother for the third time.






